## ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

### SUMMARY

#### **Final Offer Price and Net Proceeds from the Share Offer**

- The Offer Price has been agreed to be determined at HK\$0.60 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.60 per Offer Share, the amount of net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting commissions and other offering expenses payable by the Company in connection with the Share Offer, is estimated to be approximately HK\$118.4 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Net proceeds from the Share Offer” in this announcement.

#### **Applications under the Public Offer and the Employee Preferential Offering**

- The Public Offer Shares initially offered under the Public Offer (including the Employee Preferential Offering) have been very significantly over-subscribed. A total of 23,193 valid applications were received for a total of 2,009,292,000 Public Offer Shares, equivalent to approximately 80.37 times of the total number of 25,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the reallocation procedures as described in the section headed “Structure and Conditions of the Share Offer — Reallocation and Clawback” in the Prospectus have been applied. As the number of Offer Shares validly applied for in the Public Offer represents 50 times or more but less than 100 times the number of Offer Shares initially available for subscription under the Public Offer, a total of 75,000,000 Offer Shares have been reallocated to the Public Offer from the Placing, so that the total number of the Offer Shares under the Public Offer have been increased to 100,000,000 Offer Shares, representing 40% of the total number of the Offer Shares available under the Share Offer.
- A total of 17 valid applications were received pursuant to the Employee Preferential Offering on **PINK** Application Forms for a total of 2,772,000 Employee Reserved Shares, representing approximately 1.11 times of the 2,500,000 Employee Reserved Shares initially available under the Employee Preferential Offering. As the Employee Preferential Offering has been slightly over-subscribed, none of the Employee Reserved Shares was made available for subscription by the public under the Public Offer.

## **The Placing**

- The Placing Shares offered under the Placing have been slightly over-subscribed. A total number of 232,580,750 Shares have been subscribed, representing approximately 1.03 times of the total Placing Shares initially available for subscriptions under the Placing. The final number of Placing Shares allocated to 113 placees under the Placing is 150,000,000 Placing Shares (after reallocation to the Public Offer), representing 60% of the total number of Offer Shares under the Share Offer. A total number of 1 placee has been allotted 5 board lots or less of the Placing Shares, representing approximately 0.9% of the total number of 113 placees under the Placing. This placee has been allotted approximately 0.01% of the Offer Shares under the Placing after reallocation to the Public Offer.

## **Cornerstone Investor**

- Based on the Offer Price of HK\$0.60 per Offer Share, and pursuant to the Cornerstone Investment Agreement, the Cornerstone Investor has subscribed for 5,000,000 Offer Shares, representing (a) 2.0% of the total number of the Offer Shares; and (b) 0.5% of the Shares in issue upon the completion of the Capitalisation Issue and the Share Offer. Please refer to the section headed “Cornerstone Investor” in the Prospectus for further details relating to the Cornerstone Investor.

## **Public Float**

- The Directors confirmed that no Offer Shares have been allocated to applicants who are: (a) directors or existing Shareholders of the Company or their close associates (within the meaning of the Listing Rules) whether in their own names or through nominees; or (b) core connected persons (within the meaning of the Listing Rules) of the Company. The Placing is in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules. None of the Sole Sponsor, the Joint Bookrunners, the Joint Lead Managers, the Co-Managers and the Underwriters and their respective affiliate companies and connected clients of the lead broker or of any distributors (as defined in paragraph 5(1) of Appendix 6 to the Listing Rules) have taken up any Offer Shares for its own benefit under the Placing.

- The Directors confirmed that none of the Offer Shares subscribed by the placees and the public has been financed directly or indirectly by any of the Directors, chief executive, Controlling Shareholders, substantial shareholders, or existing shareholders of the Company or any of its subsidiaries or their respective close associates, and none of the placees and the public who has subscribed the Offer Shares is accustomed to taking instructions from any of the Directors, chief executive, Controlling Shareholders, substantial shareholders or existing shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it. The Directors confirmed that none of the placees under the Placing will be placed with 10% or more of the enlarged issued share capital of the Company immediately after the Share Offer. As such, the Directors confirmed that none of the placees will become a substantial shareholder (within the meaning of the Listing Rules) of the Company after the Share Offer and there will not be any new substantial shareholder (within the meaning of the Listing Rules) of the Company immediately after the Share Offer, and the Company's public float will satisfy the minimum percentage prescribed by Rule 8.08 of the Listing Rules immediately after completion of the Share Offer that the public float of the Company will be 25% of the enlarged issued share capital of the Company. The Directors confirmed that (i) the three largest public Shareholders together do not beneficially own more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules; and (ii) the Shares will be held by at least 300 shareholders at the time of Listing in compliance with Rule 8.08(2) of the Listing Rules.

At the close of the application lists at 12:00 noon on Tuesday, 4 June 2019, a total of 23,214 applications (including applications on **WHITE**, **YELLOW** and **PINK** Application Forms and by giving **electronic application instructions** to HKSCC via CCASS) and for a total of 2,010,476,000 Public Offer Shares (including Employee Reserved Shares) were received pursuant to the Public Offer. 21 multiple or suspected multiple applications for a total of 1,184,000 Shares have been identified and rejected. None application has been rejected due to bounced cheque. After excluding these multiple or suspected multiple and rejected applications, there were a total of 23,193 valid applications (including applications on **WHITE**, **YELLOW** and **PINK** Application Forms and by giving **electronic application instructions** to HKSCC via CCASS) and for a total of 2,009,292,000 Public Offer Shares (including Employee Reserved Shares), equivalent to approximately 80.37 times of the total number of 25,000,000 Public Offer Shares initially available for subscription under the Public Offer. 5 applications have been rejected due to invalid applications which are



not completed in accordance with the instructions set out in the Application Forms. No application for more than 11,248,000 Public Offer Shares has been identified and no application for more than 2,500,000 Employee Reserved Shares has been identified.

The reallocation procedures as described in the section headed “Structure and Conditions of the Share Offer — Reallocation and Clawback” in the Prospectus have been applied. As the number of Offer Shares validly applied for in the Public Offer represents 50 times or more but less than 100 times the number of Offer Shares initially available under the Public Offer, a total of 75,000,000 Offer Shares have been reallocated to the Public Offer from the Placing, so that the total number of the Offer Shares under the Public Offer have been increased to 100,000,000 Offer Shares, representing 40% of the total number of the Offer Shares available under the Share Offer, and being allocated to 8,343 successful applicants under the Public Offer.

### **CORNERSTONE INVESTOR**

The Offer Shares to be subscribed for by the Cornerstone Investor will rank *pari passu* in all respect with the other fully paid Shares then in issue upon completion of the Share Offer and to be listed on the Stock Exchange and will be counted towards the public float of the Company. The Directors confirmed that (i) the three largest public Shareholders do not beneficially own more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules; and (ii) the Shares will be held by at least 300 shareholders at the time of Listing in compliance with Rule 8.08(2) of the Listing Rules.

Immediately following the completion of the Share Offer, 25% (without taking into account any Shares which may be issued upon the exercise of any options granted under the Share Option Scheme) of the enlarged issued share capital of the Company will be held in the hands of the public, which is in compliance with the requirements under Rule 8.08 of the Listing Rules.
